### Implementation

The **company management** has overall responsibility for delivering this policy, and is responsible for:

- Ongoing development of waste management initiatives
- Review of contracts and disposal options
- Setting of objectives and targets
- Collation and review of performance data
- Keeping abreast of industry best practise and legislative changes
- Co-ordination with other policies and initiatives across the business.
- Co-operation with "Trash Galore" in Leipzig on larger events to establish specific channels local to the event location for the distribution and sustainable re-use of event content.

Day-to-day implementation of waste initiatives rests with **operations managers** in each operational area, supported by the company management.

All **employees** and **sub-contractors** have an important role to play. Regular communication with internal and external parties promotes awareness of waste management activities and their role in delivering them.

Where appropriate, we engage with our **suppliers and business partners** to explore opportunities to generate less waste and reduce the amount of packaging associated with the products we sell.

Eventful Management is certified to and compliant with DIN ISO EN 14001:2015 (Recertification was achieved in December 2022)
